3. The vehicle shall be available for inspection ~~10:00~~ AM to 5:00 PM on any working day.

4. The Auction of the said vehicle shall be governed by the following conditions:-

- The vehicle shall be auction on "As is where basis is". The auction process will be conducted by the authorized Committee.
- The bidders are required to pay Earnest money of Rs,10000/- ( Rupees Ten thousand) only pay able by means of demand draft in favour of Director, ABVIMAS, Manali ( payment by cheque of cash shall not be accepted).
- The Quotations received without demand draft towards earnest Money will not be considered and shall be rejected.

- iv) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of Director, ABVIMAS, Manali within 3 working days of the acceptance of the bid.
- v) The earnest Money of the successful bidder will be released only after the deposit of the bid amount. In case of failure to deposit final bidding amount, the respective vehicle may once again be taken up for re-auction.
- vi) The delivery of the auctioned vehicle shall be arranged only after the successful bidder submits documentary evidence in support of residential status ( PAN Card, Adhar Card etc. in case of individual and Registration Certificate etc. I case of firms).
- vii) The auctioned vehicle shall have to be removed by the successful bidder within 7 working days of depositing the bid amount, at their own expenses, by way of either submitting the RTO transfer paper or cut chassis no. of the vehicle.
